ROBERT LEE ISD NOTICE OF TRUSTEE ELECTION

Applications for candidates to apply for a position on the Robert Lee ISD Board of Trustees may be picked up at the Robert Lee ISD Administration Office beginning Wednesday, January 16, 2019, during the hours of 8 am and 3:30 pm Monday through Friday. The

deadline for filing a candidate application is Friday, February 15, 2019, at 5 pm. Election Day will be Saturday, May 4, 2019.

Robert Lee ISD will need to elect two places for full three year terms. The three year terms of Beverly Sinclair and Erin Oleksiu, are expiring.

To be eligible to be a candidate for, or elected or appoint to, the office of school board member, a person must:

- 1. Be a United States citizen.
- 2. Be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, if applicable.
- 3. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote.
- 4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.
- 5. Have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date:
- a. For an independent candidate, the date of the regular filing deadline for a candidate's application for a place on the ballot.
- b. For a write-in candidate, the date of the election at which the candidate's name is written in.
- c. for an appointee to an office, the date the appointment is made.
- 6. Be registered to vote in the territory from which the office is elected on the date described at item 5, above.
