#### January 6, 2012 **CATEGORICAL EXCLUSION**

TO ALL INTERESTED AGENCIES AND PUBLIC **GROUPS:** 

As provided by the state environmental review process adopted in the Permanent Rules of the Texas Water Development Board (Board) 31 Texas Administrative Code §371.41 for projects to be funded through the Drinking Water State Revolving Fund (DWSRF) Program and consistent with the National Environmental Policy Act, 42 U.S. Code §4321, et seq., the Executive Administrator of the Board has determined that the proposed action identified below may be exempted from formal environmental review requirements:

City of Robert Lee, Coke County, Texas **DWSRF** Project 62514 Total Estimated Project Cost: \$3,600,000

DWSRF Funding: \$ 2,750,000

U.S. Department of Agriculture - Rural Development Funding: \$500,000

Texas Department of Agriculture – Rural Affairs Office Funding: \$350,000 The City of Robert Lee (City) is proposing to use part of a \$2,750,000 DWSRF loan to address short-term, drought emergency, and long term water supply needs. The project's compliance with NEPA will be handled separately for the proposed project's three phases. Phase I activities will allow the City of Robert Lee to install a treated water pipeline to the City of Bronte in order to meet drought emergency water supply needs. The U.S. Department of Agriculture -Rural Development (USDA-RD) approved a Finding of No Significant Impact (FNSI) on November 4, 2011 for the emergency waterline, booster pump station, a metering station at the Bronte water treatment plant (WTP), and related appurtenances. In order to satisfy the NEPA compliance requirements and fulfill DWSRF program requirements environmental review, the TWDB issued a Statement of Findings (SOF) on December 7, 2011 adopting the USDA-RD FNSI. However, the USDA-RD FNSI did not include the installation of a disinfection system at the City of Robert Lee's WTP, which is needed to assure that

transmission. The proposed disinfection system would consist of a rechlorination unit to be installed at the existing WTP site. This project element will not impact wetlands or waters of the U.S. that are Representatives that are under the jurisdiction of the U.S. Army Corps of Engineers. In addition, no impacts to significant or potentially significant cultural resources protected species or critical habitat are expected.


