CITY OF BRONTE **CURFEW ORDINANCE** NO. 18-08

An ordinance of the City of Bronte, Texas, repealing and replacing Ordinance No. 298; adopting "Curfew Hours for Minors"; defining terms; creating hours for curfew hours for minors; creating offenses for minors parents of minors, and business establishments violating curfew regulations; providing for enforcement; providing for a penalty of up to \$500 for each offense; making various findings and provisions related to the subject; containing a severability clause; repealing all other ordinances in conflict herewith; providing for publication and providing that this ordinance shall be effective from and after January 31, 2019.


