The applicant proposes to inject fluid in the Goen and Jennings Formations, R.F. Butner Lease, Well No. 11. The proposed injection well is located 4.5 miles Northwest of Bronte, Texas in the Rawlings (5100) Field, in Coke County, Texas. Fluid will be injected into strata in the subsurface depth interval from 5,000 to 5,200 feet.
