Robert Lee ISD will need to elect two places for full three year terms. The three year terms of Beverly Sinclair and Erin Oleksiu, are expiring.

To be eligible to be a candidate for, or elected or appoint to, the office of school board member, a person must:

- 1. Be a United States citizen.
- 2. Be 18 years of age or older on the first day of the term to be filled at the election or on the appointment, if date of applicable.
- 3. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated partially mentally incapacitated without the right to vote.
- 4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released

from the resulting disabilities.


