CITY OF ROBERT LEE PUBLIC NOTICE TO RESCIND BOIL WATER

On December 10, 2011 due to reduced pressure resulting from water main breaks, the Texas Commission on Environmental Quality (TCEQ) required the City of Robert Lee's Water Treatment Plant/PWS ID# 0410002, to issue a Boil Water Notice to inform customers to boil their water prior to consumption.

On December 20, 2011 City of Robert Lee water customers are notified that it is no longer necessary to boil the drinking water. After receiving results of our bacteriological samples, the water is safe for consumption. Citizens may discontinue boiling water.
