Bronte City Council meeting minutes told

September 3, 2020, Special

The Bronte City Council met in special session on Thursday, September 3, 2020, at Bronte City Hall at 5:30 pm. An audio recording can be requested through the Public Information Act through City Hall.

The meeting was called to order at 5:30 pm by Mayor Paul Gohman and a quorum was established. Those in attendance included council members Steve Hines, Ron Cooper, Stormy Vaughn, Santiago Rodriguez, Utilities Directory Ricky Royall, and City Secretary Teresa Ballard. Council member Lee Wommack arrived at 5:32 pm.

The Pledge of Allegiance was

recited by those in chambers and prayer was offered by Paul Gohman.

Stormy Vaughn made the motion to approve the Robert Lee rate increase, effective January 1, 2021. She was seconded by Ron Cooper and the motion passed with a vote of 5 - 0.

The goal of the workshop is for the mayor and city council members to share and discuss elements of the FY2020-2021 Operating Budget. The FY2020 Water Fund budget was discussed.

Stormy Vaughn asked if the city could apply for a USDA grant to obtain a new mower. Ricky Royall replied yes but that it will take time, however the city is looking to

Ricky Royall explained the proposed water rate schedule increases of 5% or 10%. The council discussed and approved not to go up on the water base rate up to 1 meter, and the first two tiers 3,001 - 12,000 gallons and 12,001 -25,000 gallons for inside and outside city limit residents. The council approved for 10% for all other changes to water rates. Ricky Royall will make the changes to the revenue budget and water fee schedule as discussed by the council. He will send it back to the council for final approval.

The council would like to fix/ replace the fire hydrants and paint, depending on water pressure, at some point in this next budget year.

With there being no further business, the meeting adjourned at 6:30 pm.


