The Commissioners Court is considering possible consolidation of the presently existing two Justice of the Peace Precincts into a single, county-wide Justice of thePeace Precinct, and the elimination of the office of Justice of the Peace in one of the existing precincts. As a consequence, there will also be a reduction in the number of Constables from two to a single, county-wide Constable's office. There will be no other changes in the existing boundaries Commissioners precincts, or the election precincts.
