analysis the Agricultural and Food Policy Center A&M at Texas University these suggests proposals would result in an average additional tax liability of \$726,104 per farm for 92 of the 94 representative farms in its database. A separate study by Iowa State University suggests that if stepped-up basis were eliminated, a full-time farmer who owns just 358 acres of farmland would see his or her tax liability from a lifetime sale increase from \$475,248 to \$860,572, or a staggering 81%
