... Proposed Amendments


(Continued from page 1) would not prohibit the imposition of a business tax measured by business activity, a tax on the production of minerals, a tax on the issuance of title insurance, or a change in the rate of a tax in existence on January 1, 2016.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes from \$15,000 to \$25,000, providing for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for those purposes on the homestead of an elderly or disabled person to reflect the increased exemption amount, authorizing the legislature to prohibit a political subdivision that has adopted an optional residence homestead exemption from ad valorem taxation from reducing the amount of or repealing the exemption, and prohibiting the enactment of a law that imposes a transfer tax on a transaction that conveys fee simple title to real property."

Proposition Number 2

HJR 75 - In 2011, voters approved a constitutional amendment to allow a surviving spouse of a 100 percent or totally disabled veteran an
