A RESOLUTION ADOPTING A WATER CONSERVATION PLAN FOR THE CITY OF BRONTE TO PROMOTE RESPONSIBLE CONSERVATION AND USE OF WATER.

WHEREAS, the City of Bronte, Texas (City), recognizes that the amount of water available to its citizens and customers is limited; and **WHEREAS**, the City desires to conserve water resources; and **WHEREAS**, the City desires to comply with the rules of the Texas Water Development Board should it decide to avail itself of various financial assistance programs found in Title 31, Texas Administrative Code Chapter 363:

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRONTE, TEXAS THAT:

Section 1. The City Council does hereby find and declare that sufficient and

timely written notice of place and subject matter of this meeting adopting this Resolution was posted. The City Council further ratifies, approves and confirms such written notice and the posting thereof.

Section 2. The City Council adopts the Water Conservation Plan attached to this Resolution. All resolutions that are in conflict with the provisions of this Resolution are hereby repealed.

Section 3. Should any paragraph, sentence, clause, phrase or word of this Resolution be declared unconstitutional or invalid for any reason, the remainder of this Resolution shall not be affected.

Section 4. The City Secretary is hereby authorized and directed to publish this Resolution.

B The Mayor or his designee is hereby directed to file a copy of the Plan and this Resolution with the Texas Water Development Board in accordance with Title 31, Chapter 363 of the Texas Administrative Code.

Section 6. This Resolution shall take effect after passage and publication.
