Several options presented to the Council. Tracy Grantham made a motion to allow the office to apply for the DK Universal Fleet Card for each employee with a City vehicle. She was seconded by Mike Stephens and the motion carried with a vote of 3 - 0.

The second reading of Ordinance 9-22 - Tax Rate 2022 was held and a motion was made by Brantly Robertson to approve of the second reading. He was seconded by Mike Stephens and the motion carried with a vote of 3 - 0.

The second reading of Ordinance 1022 - Final Budget Amendment FY 21-22 was held and a motion was made by Brantly Robertson to approve the reading. He was seconded by Mike Stephens and the motion carried.

The first reading of Ordinance 12-22 - Water Taps and Rates was held. Bronte is going to increase the City's rates for purchasing water. The City will then increase their rates to mirror the percentage increase of 3.33%. The increase for late fees is also to increase from \$4.50 to \$10 to match surrounding cities. A motion was made by Mike Stephens to approve of the first reading of the above ordinance and was seconded by Tracy Grantham. The motion carried with a vote of 3 - 0.

The second reading of Ordinance 11-22 - FY 22-23 Budget Ordinance was held. A motion was made by Tracy Grantham to approve of the second reading and was seconded by Brantly Robertson. The motion carried with a vote of 3 - 0.

A motion was made by Brantly Robertson to table the Personnel Policy amendments and was seconded by Tracy Grantham. The motion carried with a vote of 3 - 0.

Christmas decorations and pole lights was discussed. North Light Displays is having a sale on their pole mount displays. The City would like to purchase lights to begin replacing the old lights and to apply for reimbursement by EDC A. A motion was made by Tracy Grantham to approve of the project expenditure of \$2904.75 for EDC A to undertake this EDC B project. She was seconded by Brantly Robertson and the motion carried with a vote of 3 - 0.

Since the previous Code Enforcement Officer resigned, a temporary Code Enforcement Official is needed to finish reports and follow ups. The City Secretary has volunteered herself with the request that she is reimbursed for the mileage. A motion was made by Brantly Robertson to appoint Amanda Mendoza as the temporary Code Enforcement Official and to reimburse her for the mileage incurred. He was seconded by Mike Stephens and the motion

carried with a vote of 3 - 0.

The Mayor reported that the Animal Control Office and Code Enforcement Officer have both resigned and the Mayor has taken on the responsibility temporarily.

The City Superintendent informed the Council of the progress of the water tower repairs, which are scheduled for September 20, 2022. A small leak was located underneath the standpipe pedestal of the tower. The water department has been in contact with engineers to resolve this issue without interruption of service to customers.

A motion was made by Tracy Grantham to adjourn the meeting at 8:49 pm. She was seconded by Brantly Robertson and the motion carried with a vote of 3 - 0.
