Separate sealed bids for the construction of GROUND STORAGE TANK AND PRESSURE TANK REHAB will be received by Coke County, Texas c/o Coke County WSC until 10:00 A.M., October 17, 2014, at Coke County Courthouse located at 13 East 10th, Robert Lee, Texas 76945, and then at said location publicly opened and read aloud. This project consists of rehabilitating 2 ground storage tanks and 2 pressure tanks for Coke County WSC. The ground storage tanks are 70,000 gallons and 50,000 gallons and the pressure tanks are both 3,500 gallons. The rehabilitation includes recoating the interior and exterior of the tanks and replacing miscellaneous appurtenances. There is a deductible alternate bid to overcoat the tanks.

Bids will not be received from bidders who have not obtained original plans and specifications from Coke County or Jacob &

Martin. Bids shall be submitted on original documents and the entire specification book must be returned with bid. No faxes or copies of bid sheets will be accepted.

The Owner reserves the right to waive any informalities and to reject any or all bids. Bids may be held by the Owner for a period not to exceed 60 days from the date of bid opening for the purpose of reviewing the bids and investigating the qualifications of Bidders prior to awarding of the contract.

Contractors must purchase a set of CONTRACT DOCUMENTS to be considered a registered plan holder eligible to bid the

project.

A certified check or bank draft, payable to the order of the COKE COUNTY negotiable U.S. Government bonds (at par value) or a satisfactory Bid Bond executed by the Bidder and an acceptable surety in an amount equal to five percent (5%) of the total bid shall be submitted with each bid.

Bidder's attention is called to the fact that not less than the federally determined prevailing wage rate, as issued by the Texas Department of Agriculture and as set forth in the Contract Documents, must be paid on this project, and that the Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, age, or national origin. Adherence to the grant recipient's Section 3 Policy is required for contracts and subcontracts in excess of \$100,000.00.
