Well Attended Meeting! Many local citizens from both sides of Coke County were on hand Monday evening, November 15, in downtown Bronte for a special Town Hall, hosted by Bronte Economic Development. Ken Becker, Interim Director, SEED Municipal Development District in Sweetwater, was the first of the two guest speakers. He began his presentation with a series of rhetorical questions about Bronte. What do the residents think of Bronte? Do they want Bronte to grow or stay the same - remembering if a town isn't growing, it is dying? What is provided to potential businesses when they request information about Bronte? What are they learning about Bronte from its website and social media? He also discussed the necessity of caring for current and established businesses. Becker stressed that it is much easier to keep an established business than to recruit a new business to set up shop in the community. He was followed by the second guest speaker of the evening, Tara Mulanax. Mulanax is an attorney with Perdue, Brandon, Fielder, Collins, & Mott LLP. She focused on various options available to deal with dilapidated properties and/or properties with delinquent taxes. The first option explained was when a property had 5 years of delinquent taxes and had been abandoned at least one year. The properties that fit this category have a tax warrant issued and, following all due process, are seized and sold in a tax sale. She also discussed using code enforcement violations to hold a sub-standard structure hearing. Ms. Mulanax's firm is the company Coke County's local government entities use for delinquent taxes. She introduced audience members to Texas Communities Group. This organization assists entities with locating, determining the best way to obtain ownership of the distressed property, and the best way to get the property back on the tax roll. In addition to their mobile app to assist with property identification, TCG has code enforcement officers, realtors, and property management services under their corporate umbrella.

### **Utility Director's Report**

The backhoe is in San Angelo but is waiting on additional elements before delivering to the City. After this winter storm, TCEQ is implementing a prepare emergency plan preparedness that demonstrates the utility's ability to provide water per Senate Bill 3 that passed recently. There is a deadline of November 1 for submitting contact information; March 2, 2022, to submit plan; and July 1, 2022, to implement the approved plan. The cost is not known but just know that the budget will need to be

amended next year. Road base will be obtained to put down in the cemetery with the help of the county to help spread the road base.
