That estimate is looking more like \$13.8 million as of this month due to quickly rising

The next step for Bronte's City Council is to agree to perform the necessary studies required for USDA to move forward with the funding proposal. This was on the agenda at the meeting on Thursday evening, November 18, 2021. However, the council chose to table the item. Mayor Gohman pointed out to the council that only the archeology study of \$35,000 would have to be paid up front. USDA will not finalize a proposal for funding for the water project until the council votes to approve this measure.

At this meeting, Bronte City Clabe Councilman Webb forming proposed exploratory committee investigate annexing more land into the city limits of Bronte. He eventually wants encompass all land surrounding Bronte two miles out from the current city limits.

Another, and possibly more equitable, way to help defray the cost of this massive, but vital, project is for Robert Lee's city officials to vote to apply for a grant/loan to purchase more of Bronte's allotment and to pay for 33% of the new plant project.

Without water, communities will die. As a county loses residents, they lose taxpayers putting a higher tax burden on the remaining residents.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$3,384, which is one cent per \$100 tax increase from last year's budget. Zach Davidson made the motion to approve Ordinance #21-06 Levying Ad Valorem Taxes for the maintenance and


