


Being prepared is better than being miserable.

I guess if a family is prepared for that, they are prepared for most disasters. But, on a more practical note, Hurricane Sandy showed how poorly prepared most folks are when it comes to nature doing the unexpected. Closer to home, in the mid 90s and again in 2000, ice and blizzard conditions stranded Texas motorists on interstates and rural highways for as much as two days. Even closer were the evacuations caused by the Silver/Spade fire of 2008 and the Wildcat fire in 2011.

hand and ready for emergency situations whether it means evacuation or sheltering in place. These can be stored in a plastic tote, and easily carried in a vehicle if you have to evacuate or just leave on a trip.

A Basic Emergency Supply Kit should include these items.

• Water, one gallon of water per person per day for at least three days for drinking and sanitation

• Food, at least a three day supply of non-perishable food • Battery powered or hand crank radio and a NOAA Weather Radio with tone alert and extra batteries for both.

• Flashlight and extra batteries

• First aid kit

• Whistle to signal for help

• Dust masks, to help filter contaminated air along with plastic sheeting and duct tape to shelter-in-place

• Moist towelettes, garbage bags (big ones make great emergency rain ponchos) and plastic ties for personal sanitation

• Wrench or pliers to turn off utilities

• Can opener (if kit contains canned food)

Local maps

• Prescription medicines and glasses

• Matches in a waterproof container (or other fire starting items)

• Important family documents such as ID and bank account records in a waterproof container

• At least one complete change of clothing for each member of your family

• Infant formula and diapers, Food and extra water for pets (if needed)

• Cell phone charger
