The meeting was called to order at 5:30 pm by Mayor Paul Gohman and a quorum Those in was established. attendance included Mayor Gohman, Council Members Steve Hines, Santiago Rodriguez, Stormy Vaughn, and Lee Wommack, Utilities Director Ricky Royall, and City Secretary Teresa Ballard. Council Member Ron Cooper was absent.

The pledge was led by Paul Gohman and prayer was offered by Lee Wommack.

Jerome Hogan asked the council to consider a variance to move a cargo container from a property he sold to his other property on east Main Street. Stormy Vaughn made the motion to approve movement of the cargo container and was seconded by Santiago Rodriguez. motion passed with a vote of 4 -

Citizens have asked if the parade route could go on the east side of Railroad Street. Santiago Rodriguez made the motion to approve Christmas in Olde Bronte, if the route does not involve getting on Highway 277 and if the state's restrictions stay open. He was seconded by Steve Hines and the motion passed with a vote of 4 - 0 to proceed in planning Christmas in Olde Bronte.

Stormy Vaughn made the motion to approve renewal of the agreement with the Coke County Sheriff's Office. She was seconded Wommack and the motion passed with a vote of 4 - 0.

Santiago Rodriguez made the motion to renew the agreement but with deleting item number one, putting only the position instead of names.
