Tuesday's election shows country wants change

Coke County voters may have been discouraged from getting out to the polls by Tuesday's rain Only 786 or 33.85% of the county's 2,322 registered voters turned out for the General Election.

However, the voters who turned out for this election were in tune with the rest of the country as they voted extremely conservatively. Nationally, the Republican party picked up even more seats in the House of Representatives and Republicans will have the majority in the Senate for the first time since 2006. Somewhat unexpected was the sweep in the governors races across the nation by the Republicans. Not only will Texas return a Republican to the Governor's office, but so will Massachusetts, Illinois, Michigan, Wisconsin, Maryland, Florida and others.

In Texas, Republicans were overwhelmingly elected to state office. Texas Attorney General Greg Abbott will be our next Governor with 59.28% of the vote over Wendy Davis'38.88%. Other winners include US Senator John Cornyn, US Representative Mike Conaway, Lt. Governor Dan Patrick, Attorney General Ken Paxton, Comptroller Glenn Hegar, Land Commissioner George P. Bush, Agriculture Commissioner Sid Miller Railroad Commissioner Ryan Sitton, Supreme Court

Chief Justice Nathan Hecht, Supreme Court Justice Place 6 Jeff Brown, Supreme Court Justice Place 7 Jeff Boyd, Supreme Court Justice Place 8 Phil Johnson, Place 3 Court of Criminal Appeals Judge Bert Richardson, Place 4 Court of Criminal Appeals Judge Kevin Patrick Yeary, Place 9 Court of Criminal Appeals Judge David Newell, State Representative Drew Darby, and 3rd Court of Appeals District Chief Justice Jeff Rose. The Proposition to use and dedicate money transferred to the state highway fund also passed statewide with 79.78% of the vote.

With a majority of 93.65%, straight ticket Republican votes cast in Coke County definitely overshadowed the Democrat straight tickets of 6.35% (339-23). In fact, Ryan Lange, the Libertarian opposing Representative Mike Conaway received more votes in Coke County than there were Democrat straight tickets cast with a total of 52 votes. However, the majority of Coke County's voters chose not to vote straight ticket for one of the parties.


