Our volunteers will be carefully screened. Our dining room will not be open this year and we'll limit fellowship to socially distant interactions with takeout and deliveries. We typically

serve around 700 meals and this year, we hope to do the same in a safe way so that next year we can return to the fellowship that is so important to our community.

Between now and December 25th, there are many opportunities to improve the Christmas season. It does not require extravagance. It might be as simple as checking in on older neighbor whose loved ones are fewer and far between. It might be supporting a local toy drive. It might be reassuring a retail clerk who is fighting

holiday stress, stressed-out shoppers, AND a dangerous pandemic all at once.

Whatever the case may be, I hope and pray that each of us will look across our community, at familiar faces and strangers, and find a way to make Christmas something happy, not merely a struggle for survival.
