Courts continue to change dates in 2012 primary elections

Due to disputed district lines, the courts have not only changed the filing period for the 2012 primary election a couple of times, they now have changed the date of the primary election.

The filing period was last scheduled to end Thursday, December 15, 2011. It has now ended as of Monday, December 19, 2011.

The primary, originally scheduled for March 6, 2012, is now slated for April 3, 2012. This move effectively removes Texas from having a decisive say in the presidential nominee since the state will no longer be included in "Super Tuesday".

County offices up for election include Coke County Commissioners in Precincts 1 and 3, currently held by Gene Montgomery and Gaylon Pitcock; County Constables in Precincts 1 and 2, currently held by Marshall Millican and Marty Boyd respectively; County Attorney, currently held by Nancy Arthur; County Tax Assessor/Collector, currently held by Josie Dean; and County Sheriff, currently held by Wayne McCutchen.

Gene Montgomery and Gaylon Pitcock have filed to retain their seats on the commissioners' court. Wayne McCutchen has filed for re-election, Coke County Attorney Nancy Arthur, along with Precinct 2 Constable Marty Boyd and Precinct 1 Constable Marshall Millican. Incumbent Tax Assessor/Collector Josie Dean has filed by petition, along with her challenger, Kathi Cox. The applications and petitions have been picked up by the party chair and the signatures on the petitions are being verified.

Robert Lee receives funding for pipeline

The Texas Water Development Board (TWDB) today approved by resolution \$2,750,000 in financial assistance, consisting of an \$825,000 loan and \$1,925,000 loan forgiveness from the Drinking Water State Revolving Fund-Disadvantaged Community to the City of Robert Lee (Coke County) to finance water system improvements.

The City of Robert Lee (City) depends on the E.V. Spence Reservoir for its water supply, and the reservoir is currently at one percent of its capacity. The City will use these funds to build a 12-mile-long pipeline as an

emergency connection to the City of Bronte to obtain emergency water supplies. Minor improvements to the City of Robert Lee Water Treatment Plant are included in this loan to provide adequate disinfection for the emergency supplies received from the City of Bronte. The loan will also provide financing to plan and design solutions to meet the City's longterm water supply and treatment needs. The planning effort will include drilling test wells for a supplemental groundwater supply.

The City is located approximately 30 miles north of the City of San Angelo. The City's 2010 population was 1,049, and its utility system serves 602 water connections and 470 wastewater connections.

The TWDB is the state agency charged with collecting and disseminating water-related data, assisting with regional planning and preparing the State Water Plan for the development of the state's water resources. The TWDB administers cost-effective financial programs for the construction of water supply, wastewater treatment, flood control, and agricultural water conservation projects.

CORRECTION

The water in Robert Lee was reported to have been off from Saturday to Monday, December 10-12. The report should have said that the water was off intermittently during those days.
