# New law aimed at

ag sales tax abuse A new law aimed at reducing the misuse of agriculture sales tax exemptions is going into effect in January, said John Ross Copeland, president of the Coke-Sterling County Farm Bureau.

"The law creates a new tax exemption number for Texas agriculture producers," John Ross Copeland "Farmers and noted. ranchers need to take note of the change."

John Ross Copeland said the registration number requirement does not change the agriculture/timber exemption that has been in place since 1961. Anyone engaged in the production of agriculture or timber products by the comptroller. still qualifies.

In the past, anyone who bought products for use in agriculture production had only to verbally state they were sales tax exempt, and fill out a form. Beginning Jan. 1, a person claiming an exemption from sales tax on the purchase of agricultural items must provide a registration number, which will be issued

Farmers and ranchers need to apply for the tax exemption number, which starting Jan. 1, 2012 will be presented to sellers to be exempt from sales and use taxes when making agricultural purchases.
