## WCCHD Board Meeting discussed

The Board of Directors of the West Coke County Hospital District met in regular session November 29, 2016. President Pat Stephens called the meeting to order at 9:40 am and declared a quorum was present. Board members present were Sarah Green, Patsy Cason, Pat Carwile and Noel Tinkler. John Rainbolt, Administrator, and Janie Munoz, BOM, were also present at the meeting. The invocation was given by Patsy Cason. There were no absent Board members from the previous meeting, and the minutes from that meeting were approved.

The census count shows there are currently 31 residents in the facility as of the meeting date.

In the staffing update, it was reported that the facility is fully staffed, with an on-going need for prn nurses and CNA's.

Accounts receivable were discussed, as were the financial statements, which were accepted as presented.

The Administrator gave his report. He is currently working on advertising and marketing. The Music and Memory certification, as well as full therapy, provided by Synertex, available at the facility, is a tremendous marketing tool.

John also reported that there were approximately 100 children from the community present at the Halloween trick or treat party, and 263 people, residents, family members, helpers, and staff, were fed at the annual Thanksgiving meal.

A report was given on building maintenance, and changes that have been made to comply with state survey. Congratulations to John and all the staff for maintaining the facility's 4-Star rating, Best in Texas. That reflects the special love and care given to the residents 24/7, as well as keeping their surroundings clean and safe.

The new medical director at the facility is Dr. John Hunt, MD.

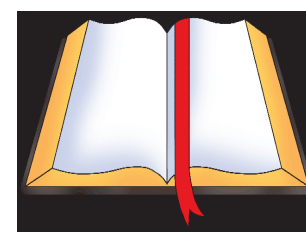
