Others to be decided and their current office holder are County (Nick Arrott), Constable (Marty Boyd), Tax Assessor/Collector (Josie Dean) Sheriff (Wayne McCutchen).

Potential candidates for the Republican primary election will need to file the necessary documents with the Coke County Republican Chair.

Coke County currently does not have a Democratic Party Chair. Potential candidates for this primary election will need to contact Glen Maxey, Primary Director of the Texas Democratic Party, at (512) 478-9800.

Each candidate will need to pay a filing fee (\$750.00) which will go toward paying for the elections to be held. If the candidate prefers not to pay a

filing fee, they may circulate and turn in a petition having at least fifty registered and verified voters' signatures.

As of Monday, December 2, Coke County Sheriff Wayne McCutchen, Commissioner Precinct 1 Donnie Robertson, and Commissioner Precinct 3 Marshall Millican have all filed to retain their seats. Constable Marty Boyd has filed as well to retain his seat and will be joined on the ballot by Billy Williams.
