b) Sewer rate residential is a low rate. Commercial rates are a little higher because more waste goes into the sanitary sewer and more of a load and higher to treat.

City Secretary's Report Auditing is being done of the utility billing, we are not charging customers for delivery and removal of trash dumpsters properly. A charge of \$45 to deliver and \$45 to remove a dumpster needs to be added to an Amended Ordinance and to start charging the customer. Water ordinance lists a \$27.50 charge to turn water off and additional \$27.50 to turn it back on. Currently we do not charge, but we need to. The City Secretary is to set

up a meeting with Mayor Gohman, Stormy Vaughn, and Republic Services next month. Utility Director's Report

Ricky Royall reported on code enforcements, 12 closed nuisances and 16 still being worked on. He would like to start taking old meters to sell them as brass in San Angelo.

Request for future agenda items included a possible drone for help to city staff service waterlines and an update on the lawsuit.

No further business, the meeting adjourned at 9:49 pm.
