Food Handlers course offered

"Texas Food Establishment Rules (TFER)" was revised and updated and will be effective October 11, 2015. A major change in the revision now requires all food employees to complete an accredited food handlers training program within 60 days employment, effective September 16, 2016.

A food handlers course accredited by the Texas Department of State Health Services is being offered by Texas A&M AgriLife Extension Service in Coke County, Texas

Food Safety - It's In Your Hands is available upon request.

This 1-2-hour course will now be required for all food service employees to help promote the service of safe food. The certificate is good for 2 years and is valid anywhere in the State of Texas. The course is a basic overview of food safety practices that are necessary to ensure that safe food is served at your establishment. Practices discussed include good personal hygiene, cross contamination, and time and temperature abuse.

To request a class, please call the Extension office at 325-453-2461. Registration can also be done in-person the day of the

A&M AgriLife Extension Office. course. The cost is \$20 per person and must be paid in full before the course begins.

> The class is taught in English, but Spanish handouts are available if requested advance.
