The following incumbents have filed for re-election in the Republican Primary by turning in their forms and filing fee to Republican County Chair Deborah Bailey: County Judge Hal Spain, County Treasurer Therese Emert, Justice of the Peace Russell Johnson, and Precinct 4 Commissioner Joe Sefcik.
