### Local Entity Filing Period ends today

The filing period for the May 1, 2021, local government entity elections ends today, Friday, February 12, 2021. Ordinarily, there is a full year between elections. Due to Covid, there is only a six month period between the 2020 election and the 2021 election. The last local entity election was held in conjunction with the general election on November 3, 2020.

The City of Robert Lee will hold an election for the council member terms currently held by Becca McGuire and Tracy Grantham. The seat vacated by Jason Moran when he was elected Mayor is also on the ballot. David Lewis and Joshua Tennison have filed for the election.

The City of Bronte has terms for three council positions. These are two year terms. The offices are currently held by Ron Cooper, Stormy Vaughn and Santiago Rodriguez. Tomas Paul Jowers and Clabe Franklin Webb have turned in the applications for a place on the ballot.

Bronte ISD will hold an

election to elect three members to the Board of Trustees. These are three year terms currently held by Ashley Braswell, Terry Queen and Blake Braswell. As of presstime, only Ashley Braswell has filed for the election.

Robert Lee ISD will also hold an election to elect three members to the Board of Trustees. These are three year terms currently held by George Grim, Wes Washam and Tom Sawyer, Jr. All incumbents have filed for re-election.

West Coke County Hospital District has two two year terms expiring for their Board of Trustees. The terms of Noel Tinkler and Beverly Burdett are expiring. Both incumbents have filed for re-election. They will be joined on the ballot by Betty Lewis.

East Coke County Hospital District Board of Trustees has two two year terms expiring. These offices are currently held by Gina McCutchen and Jerita Taylor. Both incumbents have filed for re-election.

### Current Covid numbers fall further

Reported COVID cases showed another sizable decrease this week in Coke County. Total confirmed plus probable cases as of Wednesday, February 3, 2021 were at 17 compared to 26 cases being reported last week. Of those 17 current cases, 5 were reported as lab confirmed with 12 probables.

The breakdown as to location of current cases consists of Bronte – 11 cases, Robert Lee – 5, and Blackwell - 1. Overall for the length of the pandemic, the State Health Department Dashboard lists Coke County with 211 confirmed cases, and 232 probables, for a total of 443. 417 cases are listed as recovered,

along with 11 fatalities.

I have several sources that county residents may use to register and be placed on a list to receive information for scheduling once more vaccine becomes available in our area. The link for the first website can be found at https://www.surveymonkey.com/r/LXX7S6V.

As we reported previously, the San Angelo Health Department has opened up registration for residents 65 and older, and you can register on their website, which is cosatx.us/vaccineform, and be placed on the list to receive the vaccine as it becomes available.

The Ballinger Hospital Clinic

also has a registration process, and you can contact them at (325) 365-5737. You may also contact shannonhealth.com and click on the COVID tab to register. Additional registration opportunities may also be available at either HEB Pharmacy location in San Residents Angelo. reminded that only those 65 years or older or those with special medical conditions are eligible to register for the

vaccine at this time.

#### Pancake supper set for February 16
