Filing period for local entity elections ends today

government entity elections ends today, Friday, February 14, 2020. The elections will be held Saturday, May 2, 2020.

Local entities to be included in the elections are City of Robert Lee, City of Bronte, Bronte ISD, Robert Lee ISD, West Coke County Hospital District, and East Coke County Hospital District.

As of Tuesday, February 11, 2020, the following have filed for their place on the ballot.

Paul Gohman, City of Bronte Mayor, has filed for re-election, with Gwen Dyess, Tiffany Harendt, and John Graham filing for seats on the Council. Incumbents Steve Hines and Lee Wommack have not filed.
