High School seniors interested in a future in agriculture are eligible. Each of TFB's 13 districts will award one \$1,000.

and

#### Memorial/Honorary **District Scholarships**

In each of the 13 TFB districts, four students will be awarded \$1,500 scholarships. Three students from each district will also be awarded a \$1,000 scholarship.

### Young Farmer & Rancher **Enrolled Scholarship**

YF&R Enrolled The Scholarship is for students already in college. Applicants must have a minimum of 45 credit hours and a GPA of 2.5 or higher to qualify. Three \$2,000 scholarships will be awarded.

## Student Teaching Award

Agriculture Four senior Education students will receive the Texas Farm Bureau Student Teaching Award each semester. The scholarships, valued at \$2,500, aims to help students cover expenses during their spring semester of off-campus student teaching. Students who will be student teaching offcampus in fall 2020 or spring 2021 are encouraged to apply.

## **TSTC Scholarships**

TFB has made scholarship funds available for first-year and enrolled students attending Texas State Technical College \$1.000 (TSTC). Fifty scholarships are awarded on a first-come, first-served basis through the Texan Success Scholarship. There are also five \$1,000 scholarships for TFB members entering their second year at TSTC. Another \$5,000 is available through the "helping hands" scholarship, which is meant to help students with unexpected cots that are not usually covered by traditional scholarships.

### SM True Jr Agriculture Scholar Award

To acknowledge former TFB President SM True Jr, a \$20,000 scholarship was established for college students with at least 60 hours of college credit and declared agriculture as their major. Applicants must submit a completed application and two letters of recommendation - one from the county Farm Bureau president and one from the dean or head of the agriculture department of the applicant's college or university. Students are enouraged to apply at the end of their sophomore ear for prestigious TFB's most scholarship.

proposed changes to the 2020-2021 Statewide Recreational Hunting Proclamation, with input to be considered before any action by the Texas Parks and Wildlife Commission at its March 26 public hearing:

Implement rules to administer an automated process for the application and issuance of pronghorn and antlerless mule deer permits.

Establish seasons and bag limits for the take of migratory game birds for 2020-2021

Decrease the daily bag limit for scaup from three to one in all zones.

Decrease the daily bag limit for light goose daily bag limit from 20 to 10 during the regular season in both zones.

Shift goose seasons and light goose conservation season in the Western Zone one week later than in previous years.

Shift snipe hunting season dates two weeks later than in previous years.

Once the proposed regulations are published in the Texas Register, comments on the changes can be provided on the TPWD public comment page until March 25.


