Early voting in the March 1, 2022, primary election will begin Monday, February 14, 2022 and continue through Friday, February 25, 2022.

Offices up for election include County Judge, currently held by Hal Spain; County Treasurer, currently held by Therese Emert; Justice of the Peace, currently held by Russell Johnson; County/District Clerk, currently held by Monica Reyes; Commissioner Precinct 2, currently held by Paul Williams; and Commissioner Precinct 4, currently held by Joe Sefcik.

Earlier this year, scraps of shorts and tennis shoes were found and identified as those worn by Brandon Lawson when he disappeared August 9, 2013. The clothing was found on ground searched multiple times in the days, weeks, and months following Lawson's disappearance. The searches were conducted on foot, by helicopter, ATV, on horseback, and using cadaver dogs.
