Current Covid numbers continue downward trend

By Hal Spain COVID cases Reported showed another decrease this week in Coke County. Total confirmed plus probable cases as of Wednesday, January 27, 2021 were at 26 compared to 31 cases being reported last week. Of those 26 current cases, 4 were reported as lab confirmed with 22 probables.

The breakdown as to location of current cases consists of Bronte - 18 cases and Robert Lee – 4. Overall for the length of the pandemic, the State Health Department Dashboard lists Coke County with 206 confirmed cases, and 229 probables, for a total of 435. 400 cases are listed as recovered, along with 11 fatalities.

The filing period for the May 1, 2021, local government entity elections began Wednesday, January 13, 2021, and will end Friday, February 12, 2021. Ordinarily, there is a full year between elections. Due to Covid, there is only a six month period between the 2020 election and the 2021 election. The last local entity election was held in conjunction with the general election on November 3, 2020.

The City of Robert Lee will hold an election for the council member terms currently held by Becca McGuire and Tracy Grantham. The seat vacated by Jason Moran when he was elected Mayor is also on the ballot.

The City of Bronte has terms for three council positions. These are two year terms. The offices are currently held by Ron Cooper, Stormy Vaughn and Santiago Rodriguez.

Bronte ISD will hold an election to elect three members to the Board of Trustees. These are three year terms currently held by Ashley Braswell, Terry Queen and Blake Braswell.

Robert Lee ISD will also hold an election to elect three members to the Board of Trustees. These are three year terms currently held by George Grim, Wes Washam and Tom Sawyer, Jr.

West Coke County Hospital District has two two year terms expiring for their Board of Trustees. The terms of Noel Tinkler and Beverly Burdett are expiring.

East Coke County Hospital District Board of Trustees has two two year terms expiring. These offices are currently held by Gina McCutchen and Jerita
