# Could Bronte flood once again?

Coke County Soil and Water Conservation District, District Technician Could history repeat itself in Bronte, Texas? In 1953, North of Bronte received 11 inches and Bronte received 8 inches of rain over a period of four hours. All stores flooded and residents were forced to flee flood waters. All bridges in Precinct 2 were impassable and fire trucks were used to rescue people from homes. Typhoid shots had to be given to residents due to a lack of proper sewage system caused by the flood waters. Damages were estimated to cost \$75,000 -\$100,000 for rebuilding and repairing roads, bridges, highways, terraces, railroads,

and loss of livestock. Starting in 1962, construction

by Erin Oleksiuk, began on a series of six dams that would protect Bronte from the waters in West, Middle, and East Kickapoo creeks that all merge in the town. The Kickapoo Water Control Improvement District formed and became a taxing entity for some residents in East Coke County.

In the City of Robert Lee elections, Jason Moran has filed for Mayor with Daniel Jasso for a seat on the City Council. The Robert Lee City Council has two seats open the city vacated by Wyatt Hopson and the seat held by Brandi Brosh.

The seats of Jodie Arrott and John Seales are up for election on the Bronte ISD Board of Trustees, with Jodie Arrott filing for re-election.

Irma Roberts and Jeffie Roberts have both filed for reelection the the Robert Lee ISD Board of Trustees.
