Like any objective philosopher, he also saw that what was bad for the goose was also bad for the gander, so to speak. The problem was not centralizing power in the hands of the wrong people, it was that centralizing power was bad. Period. No asterisks. No exceptions for putting the good guys in charge. Lord Acton famously wrote that "power tends to corrupt and absolute power corrupts absolutely." So it is with centralizing power, no matter whether we agree with the guys in charge or not. No matter who is at the controls, we would ultimately want for bread at their hands. And they sure wouldn't fix the potholes, either!

This is a multi-week topic, so buckle in for a ride that leads us through Adam Smith (two of them, actually!), Wendell Berry, G.K. Chesterton, and the future of rural America.
