Government purchases of Small Arms Ammunition discussed

By Johnny Kirby Jake McGuigan, Director of State Affairs and Government Relations for the National Shooting Sports Foundation, said that widely recently reported federal ammunition purchases have sparked conspiracy-type fears among gun owners. They are worried that the federal government is trying to crack down on second amendment rights via the back door by limiting the ammo available to gun owners. These fears are likely justified when we examine the government purchases.

A little more than a year ago, Social the Security Administration put in a request for 174,000 rounds of .357 SIG 125 grain hollow-point bullets. Before that, the Department of Agriculture requested 320,000 rounds. Even stranger than these is one from the National Oceanic and Atmospheric Administration requesting 46,000 rounds of small arms ammo. Really? Do the meteorologists need ammunition? Does NOAA feel the need to defend themselves from an irate public for bad weather forecasts?

The US Postal Service has also put in a request for assorted small arms ammunition

The Department of Security Homeland has requested 450 million rounds at the same time the FBI separately asked for an additional purchase of 100 million hollow-point rounds. Since the Department of Homeland Security is responsible for many of our enforcement agencies such as Border Patrol, Customs, I.N.S. etc., I can see the need for these purchases.


