28, 2021; and May 22 - 23, 2021.

Quail season will statewide October 31, 2020 through February 28, 2021, with a daily bag limit of 15 and a possession limit of 45.

Legal shooting hours for all game animals and nonmigratory game birds are from one-half hour before sunrise to one-half hour after sunset.

Hunters are reminded that licenses are on sale now for the 2020-2021 hunting seasons and can be purchased through the agency's 28 law enforcement field offices, at more than 50 state parks and over 1,700 retailers across the state. Licenses may also be purchased online through the TPWD website or by phone at (800) 895-4248. Call center hours are Monday through Friday, 8 a.m. to 5 p.m. and there is a required \$5 administrative fee for each

The online transaction system is available 24/7.

Enhancements have been made to make the licensing process simpler and faster. "Expedited checkout" speeds the process of re-purchasing the same license items bought most recently within the last three years. It's also now easier to show proof-of-license. Now hunters can use a digital image of their license as proof-oflicense for any hunting that doesn't require a tag, like dove Accepted formats include: (1) a digital photo, (2) an emailed receipt, (3) within the Outdoor Annual app or the My Texas Hunt Harvest app, or 4) online purchase record.

In addition to a hunting license, anyone born after Sept. 1, 1971, must successfully complete a hunter education training course in order to hunt

phone or online transaction. legally in Texas. The TPWD Hunter Education certification is valid for life and is honored in all other states and provinces. More information about hunter education is available online. If you misplace your certification you can print a replacement online at no cost.

Hunting stamp endorsements which are required in addition to your license include an archery stamp - \$7; migratory game birds - \$7; upland game birds - \$7; and a federal migratory game bird (duck stamp) - \$25.

### **Hunting Lease License** (Types 132, 133, and 134)

Required of a landowner or landowner's agent who leases hunting rights to another person on property they own or control for pay or other consideration. The license must be displayed on the property.

License fee: \$79 for 1 through 499 acres; \$147 for 500

## **Texas Game** Warden Field Notes **Bare Necessities**

The man soon emerged wearing an oversized pair of pants. The warden then contacted dispatch, who advised that the subject was wanted on three felony warrants out of Sabine County. The man's actions and demeanor led the warden to ask a female subject with the man for consent to search their vehicle but was denied. A canine officer was called and upon arriving to the scene quickly alerted to the presence of narcotics. Meth, along with the man's wallet, was located inside a pair of pants in a bookbag found in the bed of the truck. He was arrested and taken to Sabine County Jail. The case is pending.

# **Guard Gator**

In Cameron County, game wardens received a regarding an alligator that was roaming around inside a detention center facility. facility staff member had reportedly stepped on its tail while exiting his vehicle in the parking lot. With the assistance of the facility staff, the wardens were able to safely relocate the almost 11-foot-long alligator.

### **Tell Tailed Sign**

After an initial complainant of a Felon in Possession of Firearms and Taking a Deer in Closed Season, a Williamson County game warden obtained a search warrant on a local residence. Assisted by wardens from Travis County, Bell County and Milam County, the team executed the search and secured the house. They located a .410 shotgun with 15 boxes of ammo, meth, three deer antlers and deer meat in the freezer A white-tailed deer carcass was also dug up in the backyard of the home. Two of the wardens received information of the suspect's possible location along with a description of the suspect's girlfriend's vehicle. Wardens intercepted the vehicle and conducted a field interview. The girlfriend confessed that she had dropped her boyfriend off nearby and that he had recently shot a white-tailed deer and a feral hog. The Williamson
