The Board of Directors of the West Coke County Hospital District met in regular session February 26, 2019.

President Pat Stephens called the meeting to order at 9:35 am and declared a quorum was present. Board members present were Pat Carwile, Noel Tinkler and Beverly Burdett. Houston McGuire - RLCC Administrator, Roger Alexander - WCCHD Administrator, Chris Martin - Consultant, and Janie Munoz - BOM, were also present at the meeting.

The invocation was given by Chris Martin.

There was one visitor, Ms Faith Tyler from APEX Clean Energy, representing Grape Creek Wind renewable energy.

There were no absent board members from the previous meeting, and the minutes from that meeting were approved.

Houston gave the administrator's report.

There are 39 residents in the Care Center as of the meeting date. The facility is still in need of CNAs for the night shift, as well as a day nurse.

Accounts receivable were reviewed and discussed, and the DSO was 46 for the month.

Houston reported that the fire wall repair has been completed, the new door for the laundry has

been installed, and there are some plumbing issues currently being addressed. The Medicare cost report has been completed, and Houston is now working on the Medicaid cost report, due the end of April.

An update on the QIPP program was given.

The financial report will be provided to the Board at a later date.

The Board received and approved a bid for property in the area.

The board broke for a delicious lunch at the facility; again enjoying the residents' choice for a monthly meal.

Future agenda items were discussed, and the next regular Board meeting will be March 29, 2019, at 9:30 am. The public is invited to attend.

Looking at the facility calendar, March will be ushered in with regular activities, until the time change on March 10, when we spring forward with Daylight Savings Time. 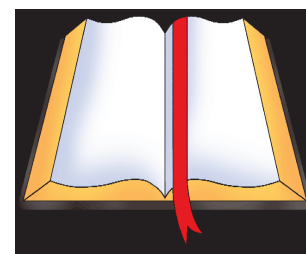
