Ricky Royall will talk to Mr. McNeal to get more information needed for certification. Lee Wommack would like this tabled until Ricky Royall has a chance to review information given to him. This item was tabled until then.

It was considered to amend container information on Sanitation Ordinance #18-05 to Section F - Collection Charges and Section I - Convenient Center.

- Republic Services meeting report - notes from Stormy Vaughn
- Gate fee at Convenient
- Charge current rate for delivery and pickup of 2y, 4y, 6y, and 8y containers that customers request.

Mayor Gohman ran down the issues:

- 1) Charging delivery and pickup charge on containers;
- 2) Adding gate fee;
- 3) Get price from Republic Services for curbside service.

Stormy Vaughn made a motion to approve adding the current rate for delivery and pickup for containers that customers request and also a motion to charge \$20 for gate fee or to be determined at the Convenient Center, moving the \$2 Convenient Center charge to the curbside service fee quarterly and taking away the \$2 of the outside residents that won't be getting curbside service. She was seconded by Santiago Rodriguez and the motion passed with a vote of 4 -1, Lee Wommack abstained. The Council will contact Republic Services to get pricing for curbside and how far out do we need to get on schedule.

Discussion was held on amending/archiving Ordinance #345 and adopting 2018 International Residential Building Code Ordinance #19-01. Ricky Royall just received the 2018 residential building code book and needs to review it. This item was tabled.

Discussion was held on amending/archiving Dangerous Building Ordinance #368 and adopting new Dangerous Building Ordnance #19-02. This time was tabled.

Discussion was held on Water Service Credit agreement for volunteer fire department/EMS staff. Teresa Ballard reported on findings from water service credits and could not find a stating volunteers get the credit. She would like the Council to consider writing procedures so city staff can follow and also add something that volunteers will also comply with city ordinances. If a volunteer is living with family, they do not need to change the water bill to their name.

Mayor Gohman reports that the pea patch and .9 acres at the cemetery do not have a clear title. There are about 100 plots available and it is being explored to expand for the future of Bronte. Additional items addressed are to have a pavilion to hold ceremonies and to have a cemetery maintenance committee.

Discussion was held on zoning, however the 2018 code books have just arrived so there was no action taken.

Stormy Vaughn made a motion to accept the December 20, 2018, minutes and was seconded by David Bedford. The motion passed with a vote of 4 - 1, Santiago Rodriguez abstained as he was not present at that meeting.

Stormy Vaughn made a motion to accept December bills paid and was seconded by Lee Womack. The motion passed with a vote of 5 - 0.


