ORDINANCE #1221 AN ORDINANCE OF THE CITY OF ROBERT LEE, TEXAS REGARDING THE PLACING AND LOCATION OF RECREATIONAL VEHICLE PARKS TO BE LOCATED WITHIN THE CITY OF ROBERT LEE AND PROVIDING FOR AN EFFECTIVE DATE.

Section 1 Purpose

This Ordinance is enacted in order to achieve orderly development of recreational vehicle parks (RV parks), to develop the use of land to minimize possible impacts and to promote the health, safety and general welfare of the public.



CRP Sign Up (Continued from page 1) Currently, about 27 million acres are enrolled in CRP, which is a voluntary program available to agricultural producers to help them safeguard environmentally sensitive land. Producers enrolled in CRP plant long-term, resourceconserving covers to improve the quality of water, control soil erosion and enhance wildlife habitat. Contracts on 3.3 million acres of CRP are set to expire on September 30, 2013. Producers with expiring contracts or producers with environmentally sensitive land are encouraged to evaluate their options under CRP.

Producers that are accepted in the sign-up can receive cost-share assistance to plant long-term, resource-conserving covers and receive an annual rental payment for the length of the contract (10-15 years). Producers also are encouraged to look into CRP's other enrollment opportunities offered on a continuous, non-competitive, sign-up basis and that often provide additional financial assistance.
