Surrounded by Smoke! Friday, February 28, 2020, rattled nerves in Coke County with fire sirens sounding and smoke in the air and on the horizon. With the burn ban lifted, there were eight controlled burns occurring in the county. The two fires causing concern were none of these. Blackwell, Bronte, and Robert Lee Volunteer Fire Departments were called to a controlled burn that got out of hand just over the county line in Runnels county east of Bronte off Highway 384. The departments, along with

Coke County Sheriff's Office, also responded to a very suspicious fire approximately 3 miles north of Bronte where a vehicle and RV were burning. This last fire is still under investigation.
