## Court sets new date for 2012 Texas **Primary Election**

As ordered by the United States District Court for the Western District of Texas, San Antonio Division, the 2012 Republican and Democratic Primary Elections will be held May 29. Per the Court's Order, the runoff for the May 29 Primary Election is scheduled for July 31. The Court's Order can be found at www.sos.state.tx.us.

"I am pleased Texas voters and candidates now have certainty when the 2012 primary and runoff elections will be held in Texas," said Secretary of State Hope Andrade. "I urge all voters who want to make their mark on Texas by casting a ballot in these critical primary elections to verify they are registered to vote, by visiting www.VoteTexas.gov. Texans who are eligible, but not yet registered will find the necessary information directing them how they can become registered voters."

## Texas Republicans accepting filings

On Thursday afternoon, March 1, the San Antonio three-judge federal panel issued an order setting a May 29th Primary Election and a related administrative calendar for the election.

Of particular importance the order sets a re-opened filing period for the primary ballot, which will commence on Friday morning, March 2, at 9 am and will run through Friday, March 9, at 6 pm.

The Republican Party of Texas will be accepting filing applications at their Austin headquarters at 1108 Lavaca, Suite 500, Austin, TX 78701, for all candidates who are required to file with the State Party instead of their county chairman. This office is closed on Saturday and Sunday.

Candidates who filed during the prior filing period in late 2011 who still wish to seek the same office need not re-file their applications, assuming no information contained therein has subsequently been rendered inaccurate.
