If the request for a contested case hearing is filed on behalf of a group or association the request must or association, the request must designate the group's representative for receiving future correspondence;

identify an individual member of the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration of for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled

Commission meeting. The Commissioner will only grant a contested case hearing on disputed issues of fact that are relevant and metericle the Commissioner designed material to the Commission's decision on the application. Further, the Commissioner will only grant a hearing on issues that were raised in timely filed comments that were not subsequently withdrawn. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met. MAILING LIST. If you submit
