The driver exited the vehicle and ran from Deputy Burdett who followed him into the backyard of 1417 Childress. At that point, Deputy Burdett took the subject into custody. Robert Clark, 18 years old and a resident of Robert Lee, was booked into the Mitchell County jail on two state jail felony charges. The charges include unauthorized use of a motor vehicle and evading arrest with a motor vehicle. It is believed the vehicle may be a total loss and the cost of repairing or replacing the fire hydrant is in excess of \$3,000.00.

Robert Lee ISD Bond Election detailed

The Robert Lee Independent School District has called a \$6,000,000 Bond Election for May 4, 2019. The bond money will go toward the following.

- · Renovation of the old gym and locker rooms.
- Resurface the two current tennis courts and build four more tennis courts.
- Renovate the old high school hall between the new and old gyms.
- Convert the current football storage into a training room and small storage.
- · Build a new covered parking for seven buses.
- · Resurface the back parking

Robert Lee ISD has issued several statements regarding this Bond Election. They include the following.

bond election, if "The approved by voters, combined with the other district debt, will require a projected Interest & Sinking Fun (I&S) Tax Rate of no more than 42 cents, which is the District's current 2018-2019

I&S tax rate. So the passage of this bond election will not result in a tax rate increase."

"Taxpayers that are 65 and over will not have their taxes go above the frozen levy amount/ ceiling that was established whenever the Over 65 exemption was granted."

"The bonds will initially have a 20 year term/payback period with a fixed tax exempt interest, however they will have a 7 year call option that will allow for them to be paid off early if the District is able to do so."

"Taxes levied for bond payments are not subject to recapture so all taxes levied and collected for the Bond will go directly toward paying back the bond."

Early voting will begin April 22 and continue through April 30 at the Coke County Courthouse in Robert Lee.

Early Voting begins April 22 in three local elections

Early voting for the May 4 local entity election will begin April 22 and continue through April 30. Early voting for the

Robert Lee based elections will be held at the courthouse. The Bronte ISD early voting will be

held at the school in Bronte. The City of Robert Lee will hold an election for three two year terms and one special election for a one year unexpired term. Incumbents on the ballot include Ricky Green and Ann Hedges. They both filed for the two year term seats. They will be joined on the ballot by Manuel Abalos, Tracy Grantham, David Lewis, Becca McGuire and Jason Moran. Zachary Van Tine and Wyatt Hopson have filed for the one year term.

Bronte ISD will also hold an election to elect two members to the Board of Trustees. These are three year terms currently held by Shane Kelton and Josh Schoenfield. Schoenfield has filed to retain his seat. He will be joined on the ballot by David McWright and T.J. McCullough.
