**Sección 10. Conformidad con las leyes federales.** En todo lo que respecta, la Elección se llevará a cabo en conformidad con el Código. En conformidad con la Ley Federal Ayuda a América a Votar (“HAVA”) y el Código, cada lugar de votación dispondrá de por lo menos un sistema de votación equipado para personas con discapacidades, y cada uno de tales sistemas deberá ser un sistema que cuente con la certificación de cumplimiento de HAVA y el Código emitida por el Secretario de Estado de Texas.

**Sección 11.** De acuerdo con las disposiciones de la Sección 3.009(b) del Código Electoral de Texas se provee la siguiente información:

- (a) El lenguaje de la proposición que aparecerá en la boleta de votación se establece en la Sección 9 de este documento.
- (b) El propósito por el cual se han de autorizar los bonos se establece en la Sección 8 de este documento.
- (c) La cantidad del capital de las obligaciones de deuda que se ha de autorizar es de

\$6,000,000.  
 (d) Si los votantes aprueban los bonos, la Junta de Síndicos estará autorizada a imponer impuestos anuales ad valorem sobre toda propiedad gravable del Distrito, suficientes, sin límite de tasa o cantidad, para pagar el capital y el interés de los bonos y el costo de cualquier convenio crediticio celebrado en relación con los bonos.

(e) Según las condiciones del mercado de bonos en la fecha de adopción de esta Orden, la tasa de interés máxima para cualquier serie de bonos se estima en 4.50%. Dicha tasa máxima estimada se provee a título informativo, pero no es un límite sobre la tasa de interés a la que podrían venderse los bonos o cualquier serie de ellos.

(f) Si se aprueban los bonos, se podrán emitir en una serie o más, para vencer en serie en un periodo que no exceda los 25 años a partir de la fecha de emisión de cada serie de bonos.

(g) La cantidad agregada de capital pendiente de las obligaciones de deuda del Distrito al comienzo del año fiscal 2018-2019 del Distrito es de \$7,515,000.00.

(h) La cantidad agregada de

interés pendiente de las obligaciones de deuda del Distrito al comienzo del año fiscal 2018-2019 del Distrito es de \$1,701,237.50.

(i) La tasa del impuesto ad valorem del servicio de la deuda para el Distrito, para el año fiscal 2018-19 es \$0.42 por cada \$100 de tasación fiscal gravable.

She was opposed on this by Blevins and several members of the audience who had personal knowledge of the order of events.

Council Member Ann Hedges made a motion to terminate

Blevins employment with the City of Robert Lee, seconded by Council Member Ricky Green. Brosh joined in with an affirmative vote. Blevins immediately left the building. At this point, the billing clerk resigned, turned in keys and equipment, and left the building. Mayor Crenshaw returned and

began to once again preside over the meeting.

City Attorney Betty addressed the council and offered his resignation, which they declined. A voice from the audience told him to leave and Betty suggested they meet outside. Upon that challenge, Sheriff Wayne McCutchen

stepped in to advise Betty against statements like that and there was a sharp exchange between the sheriff and the attorney.

The election is set for Saturday, May 4, 2019. There are three two year terms and one one-year unexpired term on the ballot. Brosh's seat is not up

for election this time. However, both Green and Hedges are on the ballot seeking re-election. They are joined for the two year terms by Manuel Abalos, David Lewis, Tracy Grantham, Jason Moran, and Becca Skinner. Wyatt Hopson and Zach Van Tine are on the ballot for the one year unexpired term.

# Citizen Comments

“I ask for the immediate resignation of City Attorney Jeff Betty for providing advice to the Robert Lee City Council which proved to be unlawful.

As an example of this bad advice, I note the blessing he provided to the remaining members of the council at the February 4, 2019, meeting following the resignations of Janie Munoz and Roger Alexander. By law, the meeting should have been adjourned as soon as the two members resigned. However, Betty assured Council it was still legal since they began with a quorum.

As citizens of Robert Lee, we must be concerned with the counsel our city elected officials are receiving.”

“I am asking you to table any personnel decisions on tonight’s agenda.

The discrepancies rumored were due to reports of accounts not being complete and reconciled in a timely fashion by the previous administration and no longer exist. In the email regarding the media, no information was given by the City Secretary that wasn’t already a part of the open public record from the published agenda.

Your actions have now brought the attention of not one, but two investigators from the Attorney General’s office.

If you choose to fire the secretary, it will appear that you are acting for the mayor’s benefit to deflect blame from the mayor should she decide not to take a plea, but go to trial. That termination will not only be detrimental to the City of Robert Lee, but also to each of you personally since you could be sued individually as well.

I sincerely request you to reconsider and leave this decision to the council in which voters place their trust in an election just over three weeks away.”

“Based on the previous city staff stealing from the city by not being charged the full amount and not being charged a disconnect fee for non payment of their utility balance, I would like to see Brandi Brosh’s past utility payment and charge history while employed with the City of Robert Lee. If she was part of the past corruption, she has no business being on city council.

I would also like to know why you are so determined to fire Crystal Blevins. The mess this office was in when Crystal took over could not be put back together overnight. You can’t just start when you take office and go forward if it is not in balance.

You have to go back and reconcile from the first day it didn’t balance and work forward. That can take a lot of time.

How long did we go without someone who knew what they were doing in this office?

I think you all need to reconsider the firing of Crystal. Who are you going to hire, who is going to run the election?

Allyson?? You know that will be a fair election!

I request that Mayor Allyson Crenshaw resign today for the good of the City of Robert Lee.”
