Mr. Kuhlman commented how well the boys basketball teams improved from the beginning of the season and reported how Coach Rawls was very impressed. One Act Play will be holding performances soon, including a public performance on March 3 at 6 pm, a school performance on February 28 at 2:45 pm, and the district performance on March 4. The band will be at the UIL Concert and Site Reading Contest on March 3 in Ballinger.

The total Bronte ISD student count is 242, including 145 in PK - 6th grade, 21 in 7th - 8th grades, and 76 in 9th - 12th grades. The ADA is 96.3%

Mr. Siler gave an update on the current finances. Bronte ISD is a little over 50% through the school year with expenditures at a little less than 50%, so Mr. Siler has no concerns currently. There is still a lot of uncertainty from TEA regarding school finance but Mr. Siler's current estimate is that BISD is running approximately \$140,000 positive. There might be a budget amendment in March. Mr. Siler also advised that there will need to be a regarding discussion implementing drug testing for extracurricular activities. August testing would come out of this year's budget and Mr. Siler will get an estimate of the approximate cost of testing. There will also possibly need to be a discussion on a bond due to the INS tax from the solar plants.

No action was taken on amending the 2019-2020 budget.

The Board entered into executive session at 6:51 pm and came out at 8:41 pm.




The next regular board meeting will be held Wednesday, March 18, at 7 pm.
