The majority of the students have received credit for Credit Recovery classes. We still have many of our students signed up Dual Credit/Credit Recovery classes for the Spring Semester. The Ag program had a local Stock Show at the Coke County Barns on January 4, 2020. This gave the students practice for the upcoming Stock Show Season. There will also be two new foreign exchange students coming to BISD soon, as well as a Student Ag Teacher.

Mr. Siler presented the BISD student counts, with 238 total students including 144 in elementary, 21 in 7th - 8th grades, and 73 in 9th - 12th grades. ADA is at 96.14%.

Mr. Siler gave an update on ISD's financial information. A new template will be run soon. A large check has been deposited that has not been added to revenue. BISD is currently about 50% through the school year and 30% through the fiscal year. Mr. Siler touched on a function concern where an employee salary had to be reclassified and will be watching that closely. Data processing is currently at 50% realized due to paying the Region 15 bills. Current YTD: realized 1.4 million, 1.2 million expended so still ahead.

An update was given on the May Board Election. The seats held currently by John Seales and Jodie Arrott are open.

No action needed to be taken on the 2019-2020 budget.

David McWright made a motion to order the school board election on May 2, 2020. John Seales seconded. Ayes: 7, Nayes: 0. Motion passed.

David McWright made a motion, with Ashley Braswell seconding, to designate Laurie Austin as Early Voting Clerk. Ayes: 7, Nayes: 0. Motion passed.

The Board did not enter into executive session.
