The Board of Directors of the West Coke County Hospital District met in regular session March 30, 2021, in the old jail annex. President Beverly Burdett called the meeting to order at 9:39 am and declared a quorum was present. VP Pat Stephens led the invocation. Board members present were Noel Tinkler, and Judie Andrews. Houston McGuire, RLCC Administrator, Janie Munoz, BOM, and Chris Martin, Consultant, were also present at the meeting. The minutes from the previous meeting were approved and one absentee from that meeting was excused.

There were 2 visitors.

The Board adjourned into Executive Session at 9:40 and returned to Regular Session at 10:34. No action was taken.

Roger Alexander joined the meeting at 9:45.

Betty Lewis was appointed by the Board to fill the vacant term of Robert Brock. The Board welcomes Betty into this position and looks forward to working with her.

The Administrator gave his report.

The air handler has been installed and is in operation. The new freezer has also been installed. Houston is currently still waiting on the electrical bid. The new van is in operation and the Board authorized Houston to begin taking bids on a new truck.

Plans for the secure unit are still on hold.

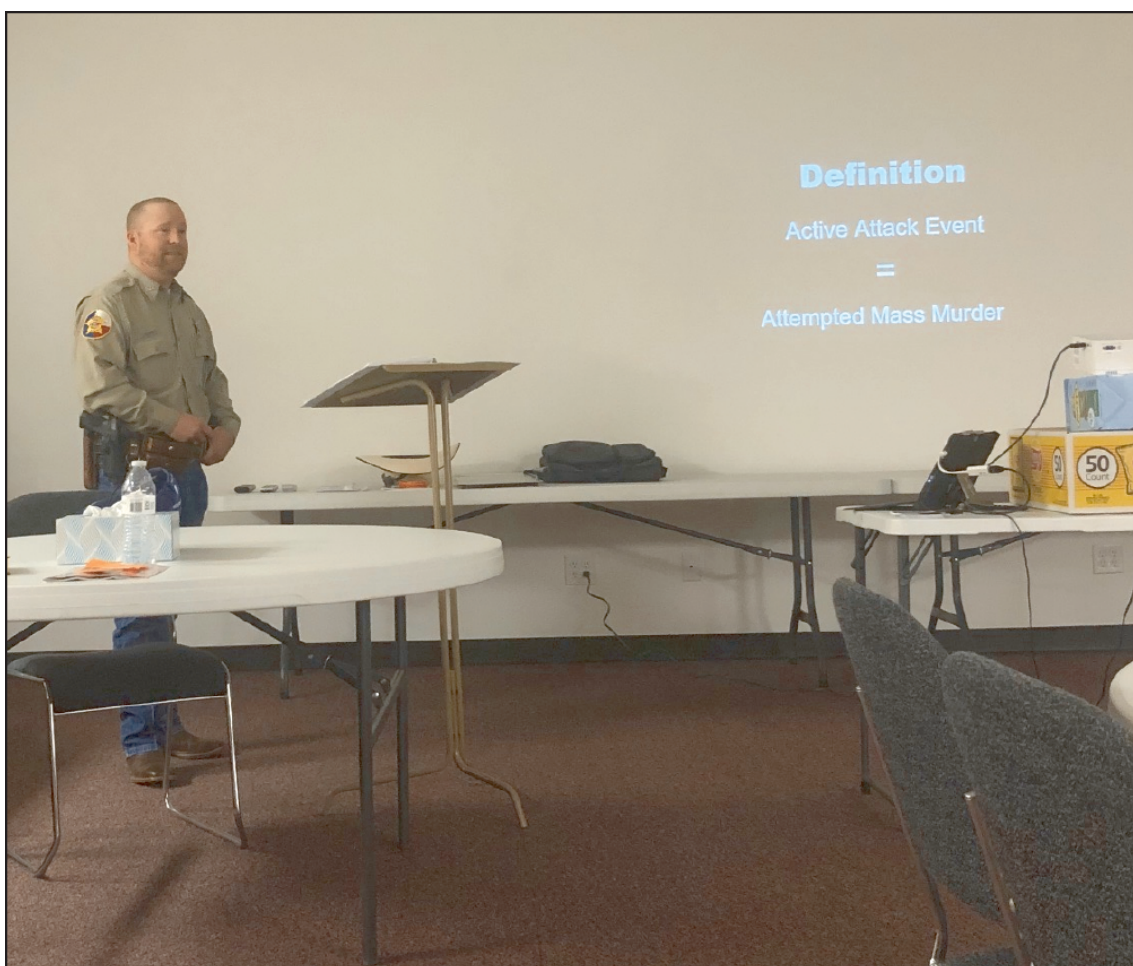
The Board voted to accept the policy for EMS and Firefighters.

Robert Lee City Council meeting minutes told

March 1, 2021

The Robert Lee City Council met in special session on Monday, March 1, 2021, at 6:30 pm at City Hall.

Those present included Mayor Jason Moran, and Council Members Becca McGuire, Tracy Grantham, Jonathan Torres, and Danny Jasso.

A quorum was determined and the meeting was declared open at 6:30 pm.

Prayer was offered and the pledge was recited by those in chambers.

Discussion was held regarding the Spring Market Vendors.

The group that hosted the Fall Vendor Market would like the Council to waive the City Vendor Permits for the Spring Market event. There will be 27 vendors at this event, which will be hosted on March 27, 2021, from 10 am to 4 pm. A motion was made by Mayor Pro Tem Tracy Grantham to waive the vendor permit fee for this event and she was seconded by Council Member Danny Jasso. The motion carried with a vote of 4 - 0.

Discussion was held regarding ACO contracts. The ACO cannot get their license due to

COVID until around June or July. It is considered paying the full amount for the contract and reevaluating the pay when they are able to test and get their license. A motion was made by Council Member Danny Jasso to approve the contract with the suggested changes to section 4 regarding payment change to the full amount of \$600 plus \$150 for gas. Council Member Becca McGuire seconded and the motion carried with a vote of 4 - 0.

The City Superintendent would like for the Council to approve up to \$5,000 to purchase road materials at his discretion.
