- Movie Theaters
- Shopping Malls (not food courts or play areas)
- Museums and Libraries
- Services provided by an individual working alone in an office.
- Golf Course operations
- Local Government Operations

The 25% and 50% restrictions do not apply to essential services. The Executive Order also addresses the controversial regulations imposed on the citizens of Harris County by their County Judge with the following statement.

“Individuals are encouraged to wear appropriate face coverings, but no jurisdiction can impose a civil or criminal penalty for failure to wear a face covering.”

It addresses hair and nail salons in this statement. “People shall avoid visiting bars, gyms, public swimming pools, interactive amusement venues such as bowling alleys and video arcades, massage establishments, tattoo studios, piercing studios, or cosmetology salons.” The restrictions on nursing homes and rehab centers were not removed by this order.

It appears Texas numbers continue to improve overall with the recovery rate approaching


the 50% mark. Testing in Texas has really increased averaging 6,000 to 10,000 new tests given per day to 10,000 to 20,000 new tests given per day.

As of Tuesday, April 28, 2020, worldwide there have been 3,091,141 cases of Covid-19

with 215,138 deaths. Of these 3,091,141 cases worldwide, 1,003,625 are in the United States with 57,608 deaths. As of 8 pm Monday, April 27, 2020, 300,384 Texans had been tested for the virus. Of those 300,384 tested, there are 26,171

confirmed cases spread over 207 of Texas’ 254 counties. Six hundred ninety Texans have lost their lives to the virus as of presstime. In Texas, 8.71% of all people tested are confirmed to have the virus, and of those confirmed cases, 2.63% result in

death. Worldwide, the rate of death of those confirmed to have Covid-19 comes in at 6.95%, up from 6.90% last week and 6.32% the week prior. For the United States, the death rate is 5.73% up from 5.37% last week and 4.13% the week prior.
