Commissioners Court minutes posted

The Coke County Commissioners Court met in regular session May 27, 2014, at the courthouse in Robert Lee. Members of the court present included County Judge, Roy Blair, Commissioner, Pct. #1 Troy Montgomery, Commissioner, Pct. #3 Gaylon Pitcock, Commissioner, Pct. #4 Bobby Blaylock. Clerk Mary Grim was also in attendance.

The meeting opened with prayer given by Comm. Blaylock and pledge to the flag was recited.

Judge Blair announced the presence of a quorum. Comm. Lee was absent.

Comm. Blaylock made a motion to approve the minutes for May 12, 2014. The motion was seconded by Comm. Montgomery. Motion carried.

No action was taken on the Burn Ban. Judge Blair had released the burn ban on May 26.

Comm. Montgomery made a motion to approve the bond for Rhonda Boone, deputy in the Tax A/C office. The motion was seconded by Comm. Pitcock. Motion carried.

EPA's proposed rule could hurt Texas farmers, ranchers

Farmers and ranchers from Coke County are telling Congress, "It's time to ditch the rule." The campaign is aimed at a new rule proposed by the Environmental Protection Agency (EPA) through the Clean

Water Act (CWA) that would essentially give EPA additional regulatory authority.

"If this rule is enacted, the implications to farmers and ranchers could be devastating," John Ross Copeland, Coke County Farm Bureau president, said. "The rule would allow the agency to take the phrase 'navigable waters' out of its definition of what can be regulated under the CWA. Without the 'navigable' clarification, the EPA would have power over all bodies of water including the water standing in my field or running in a ditch after a rain."

The ruling could have implications for homeowners, builders and businesses as well.

"Ponds, drainage, seeps and other areas where water stands would all come under EPA regulation," John Ross Copeland said. "This could give the EPA authority to tell us what we can or cannot do on our farm, home and businesses."
