#### Housing Reconstruction/ **Rehabilitation Assistance Program applications** to be taken in Bronte

Mayor Gerald Sandusky and the Bronte City Council are pleased to announce that The City of Bronte has been awarded a HOME Grant through the Department of Housing and Urban Development and the Texas Department of Housing and Community Affairs (TDHCA). The TDHCA mission is to "help Texans achieve an improved quality of life through the development of better communities."

The HOME Program provides funds to assist low income homeowners with repairs to bring their homes into compliance with local codes and construction specifications or to replace homes with a new house when repair costs are greater than the allowable limits for repairs. Assistance requires no repayment as long as the homeowner continues to own and occupy their home for fifteen years.

Applications are being taken on June 17, 2014, at 9:30 am at the Bronte City Hall. Some of the documents interested homeowners will need to bring are: copies of social security cards for all persons living in the home; copies of photo I.Ds for all persons 18 years or older living in the home; a voter registration card or a utility bill with the homeowner's name and the property address listed; six months of checking statements; six months of pay stubs; the latest savings account statement; a copy of the social security income statement; the most current year's tax receipt; and a copy of the Deed for the property showing proof of ownership. Additional documents may be required depending on individual circumstances. Those interested should plan on spending four to six hours for the application process.

Bush, nominee for Land Commissioner, Glenn Hegar, nominee for Comptroller, Ken Paxton, nominee for Attorney General, Dan Patrick, Lieutenant nominee for Governor, Sid Miller, nominee for Agriculture Commissioner, and from Ryan Sitton, nominee for Railroad Commissioner.

If a common theme could be drawn from the speeches, it would be twofold: the concerted effort that office holders and candidates are making, or will make, to control the overreaching actions of the national government, and the emphasis on faith, family and freedom that seems to be absent in the national government today.


