STATE OF TEXAS COUNTY OF COKE ORDER PROHIBITING CERTAIN FIREWORKS IN UNINCORPORATED AREAS OF COKE COUNTY, TEXAS

WHEREAS, the Texas Service has Forest determined that drought conditions exist in Coke County; and

WHEREAS, on the 10th day of June, 2013, the Commissioners Court of Coke County determined that the normal danger of fire in the unincorporated areas of Coke County is greatly enhanced by the extremely dry conditions now existing;

NOW, THEREFORE, the Commissioners Court of Coke County adopts this Order prohibiting the sale or use of restricted fireworks i n unincorporated areas of Coke County.

A. No person may sell, detonate, ignite, or in any u s e fireworks way classified under C.F.R. part. 173.100(r)(2)(10-1-86 edition), as "skyrockets with sticks" and "missiles with fins" in any portion of the unincorporated area of Coke County.

B. This Order does not prohibit:

1. common fireworks, small in size classified as Class C explosives;

2. large fireworks devices designed primarily
